- Proposal for Behavior Department Head Position and Proposal for Behavior
  Department Program Vanessa Niemi and Taylor Davis 35 minutes (7:45-8:20)
  - Taylor and Vanessa have been doing this since July
  - Have brought in \$9,000
  - Most members want to keep continuing education but dogs are not ready for regular obedience or agility classes
  - Changing attitudes has become class for reactive dogs > market what it is, not what it was supposed to be
    - Way underpriced compared to other organizations
  - Jane suggested Wallflower class for shy timid dogs
  - Proposal sent out with financials > room to grow class options
  - Proposal to have a Behavior Dept and Dept Head
  - Taylor and Vanessa think they can cover cost with classes alone
  - Believe training instructor should be paid more due to education and risk
  - A lot of demand for well run classes for reactive and shy dogs
  - Take the strain off of other classes
  - Advisory committee vet behaviorist, 2-3 people that Taylor & Vanessa could consult with
  - Marketing: want to be cohesive with how club is marketing itself but it doesn't match right now
    - Shift in market black & white training techniques vs LIMA
    - Less science > more create a connection with you & your pet

- Does not affect bylaws there's nothing preventing us from changing Organizational structure
- Karen will review Dept. Head job description, and compare to what we have.

- Discussion:
  - need is there, good idea for the pandemic dogs,
  - pricing structure compared to specialty classes and our club identity

- 3 small action items we can take
  - Welcoming space for people of all backgrounds > develop and provide educational opportunities
    - Webinar, seminar, exam different cultural norms all pertaining to dog training
  - Create community buy in > create pet food drive at club
    - Positively affects community due to Covid and job losses
    - Donate to both S Mpls People and Pets Together, N Mpls Pet Resource Center
  - Offer 3 BIPOC scholarships cover 50% of basic class fees
    - Prices may not be accessible to all backgrounds
    - Help dogs stay in their homes
    - Target where people would be most in need S Mpls People and Pets Together, N Mpls Pet Resource Center
    - Perhaps offer clicker, bag of treats, leash/collar, or \$10 at store so they are prepared
    - Anne will ask membership for donations to this program
- People and Pets Together is under Second Hand Hounds now
  - Anitra can help with introductions
  - One trainer at PPT offers classes free or reduced prices but would welcome scholarships
- Possibly create a separate non-profit if this takes off
