Managing Director's Report - Anne Schenk - 10 minutes

- Heat had big impact August 3+ closures, complaints drop out due to heat, delayed enrollment due to heat and travel
- In "22 we bounced back a bit after Labor Day, we haven't seen that yet
- Price increase is now in effect, except for conformation classes (instructor hesitant to increase based on what other schools charge)
- Puppy and Tweener enrollment now at 100%
- Shelters, rescues per news have more surrenders due to less affordable housing

New Business

Revenue/Financial Status Discussion - 30 minutes

In July, the board voted to increase class fees, conformation fees, and open ring fees. Our financial status is still a concern though and we need to focus on a plan to address the gaps.

- Club seems to lose people who are looking for pet training, ex. Teaching how to decrease treats during daily activities
- In past there was a "make your own curriculum class"
- Other clubs often organized around the classes of formal obedience
- Increase mentorship possibilities for pet training and for performance sports
- People coming for first time do not understand why there is a membership fee
- Use social media to create enthusiasm for entering trials, participating in activities
- Perks for novice entrants such as "novice bags"
- Have a member take the show secretary role might be easier for obedience instead of agility
- Obedience show and go, scent work sniff and go
- Informal sports for fun opportunities
- Possibly offer behavior consults again as another club offering

- Decorate club for holidays, themes
- Offer video opportunities for filming for video trialing
- Offer WCRL rally trials 2-3X/year
- Look for weekends when there are no trials as opportunities to reach out and do a fun activity for pet dogs and competition dogs
- Revisit pricing of CampK9 changes in structure (# dogs per trainer time has decreased) such that current price schedule is not sufficient -we're just breaking even now
- Anitra proposes to raise CampK9 fees by \$ 5 half day, \$ 10 full day to go in effect Oct 1, Charlie seconded, passed unanimously

AKC Club Promotion Mailing - Charlie Leavitt - 15 minutes

An update on how AKC can work with us on club development.

- AKC will make a mailing on our behalf if we make a club flyer to AKC registered dogs.
- AKC suggested a mix and mingle event
