Take I-35W north. Exit on the Johnson St/ Highway 88 exit. Stay right, then turn right on Highway 88. Turn left on Broadway Street. The club is located on the left after 2 blocks.

From the East:

Take I94 west, then Highway 280 north. Take a left on Broadway Street. Go 1-1/2 miles. The club will be on the right.

From the West:

Take I394 east, then I94 east. Go north on I35W. Exit on the Johnson St/ Highway 88 exit. Turn right on Highway 88. Turn left on Broadway Street. The club is located on the left after 2 blocks.

Trial will be held indoors on mats. Rally ring size 40' x 60'.

No overnight parking in the activity center parking lot except with Club permission. No dogs may be left in the building overnight.

All dogs must be held on leash or confined to crates, except when being judged or in designated warm-up areas. No Flexi leashes or prong collars are permitted in the building. No ex-pens in the building.

TCOTC assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

There will be no food service at the trial.

Trial Entry Information and Trial Regulations

Opening Date –Friday, August 15, 2025 at 6:00AM

Closing Date – Wednesday October 1, 2025 at 6:00PM

After which time entries cannot be accepted, cancelled, altered, or substituted except as provided in the American Kennel Club Rules Applying to Dog Shows, Chapter 11

Entries are acknowledged via email as soon as they are received and processed. Please review and respond right away if any changes are noted. Armband numbers are confirmed and judging programs are distributed via email for all entries. This will be shortly after closing, when final judging assignments are complete, and exhibitor armband numbers have been assigned. Premium lists for future trials will also be sent out via email. Entries must be signed by the owner or owner's agent and include agreement.

Refunds will be given for entries withdrawn in writing or via email before the closing date and time. TCOTC will give full refunds per AKC regulations for bitches that come into season after the closing date of the trial, and for no other reason. You must submit a signed statement of the dog's condition from your veterinarian on his/her office stationery along with your request for such a refund to the trial secretary at least 60 minutes before the start of the trial.

No refunds for errors on entry forms, or if a dog is absent, disqualified, or excused. No refunds if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club. We will make every effort to find all duplicate entries, but if an entry has been processed, no refund will be made.

Changes or corrections to entry forms must be received in writing or via email prior to the close of entries. Owners are responsible for correcting entry form errors.

Obedience High Jump Height is required for all entries in classes with jumps. Rally Jump Height is required for Advanced, Excellent and Master classes.

Entry Fees must be paid with entry submission for online entries. If a check is returned, we will add any bank fees to the amount due. Canadian exhibitors make fees payable in U.S. funds.

Transfers will be accepted per AKC regulations if you have earned a new title after closing, and if the class is not full. The fee difference will apply for transfers from a non-regular to a regular class. Completed and signed transfer form must be submitted to the Trial Secretary no later than 60 minutes prior to the start of judging for the trial.
